Estado de salud del primer ministro eslovaco, Robert Fico, mejora después de segundo cirugía

El primer ministro de Eslovaquia, Robert Fico, se encontraba en mejor estado de salud el sábado por la mañana, según el viceministro del país, después de haberse realizado una segunda cirugía para tratar las heridas que sufrió en un intento de asesinato el miércoles.

"Han ocurrido varios milagros", dijo el viceministro, Robert Kalinak, a los reporteros. Añadió sobre Fico que "está consciente, con todas las limitaciones de esta lesión grave".

Kalinak hizo estas declaraciones frente al Hospital Universitario F.D. Roosevelt en la ciudad central de Banska Bystrica, donde Fico fue trasladado después de ser disparado varias veces por un hombre armado.

El tiroteo, que tuvo lugar en la ciudad de Handlova, en el centro de Eslovaquia, fue el ataque más grave contra un líder europeo en décadas.

Fico fue disparado varias veces, pero Kalinak explicó durante una entrevista televisiva el sábado que una de las heridas representaba el mayor riesgo para la salud de Fico.

El viernes, dijo Kalinak, los médicos extirparon tejido infectado de la zona de esa herida en la segunda cirugía de emergencia que Fico ha tenido desde el ataque.

Debido a la gravedad de sus lesiones, dijo Kalinak, Fico no podrá ser trasladado a Bratislava, la capital y ciudad más grande de Eslovaquia, al menos durante unos días más.

También el sábado por la mañana, en la ciudad de Pezinok, en el oeste de Eslovaquia, a unos 12 millas de Bratislava, los reporteros eslovacos e internacionales esperaban frente a un edificio del tribunal mientras las fuerzas policiales especiales aseguraban los alrededores antes de traer al sospechoso para una comparecencia ante un juez.

Después de una audiencia a puertas cerradas, el juez ordenó que el sospechoso permanecería bajo custodia hasta que las autoridades puedan acusarlo y enjuiciarlo.

"La razón de la detención es el miedo a una posible fuga, así como la continuación de la actividad criminal", dijo Katarina Kudjakova, portavoz del tribunal.
