Any information Skrill transmits is protected by the highest standard of encryption – Payment Card Industry Data Security Standards Level 1 (PCI-DSS Level 1). Put simply, this means that any attempt made to intercept your data will be unsuccessful, as it will be unreadable.

Furthermore, Skrill

also allows users to enable two-factor authentication (2FA). This allows you to use the Google Authenticator app to provide an extra layer of security.
