A maioria das áreas marinhas protegidas da Europa, criadas para proteger espécies e habitats não cumprirá os objetivos de conservação porque fornecem apenas proteção "marginal" contra atividades industriais como dragagem.

Os baixos níveis de proteção onabet deolane 86% das áreas marinhas protegidas (MPAs) deixaram a UE longe dos seus objetivos para 2030, que são projetados com o objetivo reduzir os riscos da extinção dessas espécies. A União Europeia tem como objectivo proteger 30% do seu mar até ao ano 2030 e 10% "estritamente" estão protegidos contra atividades prejudiciais "É a primeira avaliação de onde estamos onabet deolane termos da proteção", disse Juliette Aminian-Biquet, principal autora do artigo e investigadora na Universidade Algarve. Centro Português para as ciências marinhas: "Isto mostra que já começamos por proteger os nossos oceanos".

O documento concluiu que atingir o objetivo de proteção estrita da UE onabet deolane 10% exigirá "mudanças radicais" na regulamentação das atividades nos seus santuários marinhos.

"Fazer com que a UE faça qualquer coisa sobre este tópico é extremamente difícil, já o regulamento teria de ser juridicamente vinculativo", disse Aminian-Biquet. "Caberá aos estados ou autoridades regionais tomar medidas para atingir esses objetivos."

Um porta-voz da Comissão Europeia disse: "A comissão toma nota das publicações muito recentes e suas principais conclusões sumárias", dizendo que pediu aos Estados membros para gerenciar todos os MPAs onabet deolane conformidade com as diretivas relevantes, bem como compromissos europeus de proteger 30% dos territórios marinhos até 2030. Eles acrescentaram ainda mais o plano 2024 do Plano Marinha recomendado pelos estados Membros a eliminar gradualmente arrasto no fundo nos PMOs por volta deste ano (até 2025).

A eliminação gradual foi rejeitada pelo Parlamento Europeu onabet deolane janeiro e a maioria dos Estados da UE ainda não definiu medidas para o arrasto de fundo, com exceção do país grego que se tornou no primeiro Estado-membro europeu na proibição das pescas por baixo nos

MPAs neste ano.
