## Copa América: análise da decisão de eliminar o tempo extra nos jogos eliminatórios

Os fãs de futebol que estão se deliciando com a Copa América e o Euro 2024, que estão sendo realizados simultaneamente onabet v1 continentes diferentes, notaram uma diferença fundamental entre os dois torneios: não há tempo extra nos jogos eliminatórios da Copa América.

A Conmebol, órgão governante do futebol sul-americano, decidiu que não seria jogado tempo extra se os placares estivessem empatados ao final do tempo regulamentar nas quartas e semifinais. Em vez disso, como aconteceu onabet v1 três dos quatro jogos das quartas de final, as equipes pularam diretamente para uma disputa de pênaltis. Apenas se o placar estiver empatado entre Argentina e Colômbia no final dos 90 minutos na final haverá o período extra tradicional de 30 minutos.

## Vantagens e desvantagens da decisão

A eliminação do tempo extra tem suas desvantagens. O confronto entre Uruguai e Brasil na última-oitava levantou um ponto controverso porque a equipe de Marcelo Bielsa ficou com um homem a menos depois que Nahitan Nández foi expulso no 74º minuto. A Uruguai conseguiu segurar o empate onabet v1 1 a 1 antes de garantir onabet v1 vaga nas semifinais com uma vitória por 4 a 2 na disputa de pênaltis. Se a prática comum de tempo extra onabet v1 jogos empatados tivesse sido mantida, no entanto, eles teriam que jogar mais meia hora com um homem a menos.

"Quando estávamos com um homem a menos, decidimos nos dedicar a defender onabet v1 nossa metade do campo", disse Bielsa após o jogo.

Na Copa América, a Uruguai teria que se defender por mais 45 minutos. Mas, onabet v1 vez disso, eles só precisaram sentar-se por 20 minutos, com o jogo se transformando onabet v1 parte exercício de desperdício de tempo e parte briga.

## História da Copa América sem tempo extra

Embora a falta de tempo extra na Copa América tenha despertado atenção geral, o formato não é novo. Por maior parte da história de 108 anos do torneio, não foi usado tempo extra antes da

final; e entre 1995 e 2004, não houve tempo extra mesmo na final. A única edição onabet v1 que o tempo extra foi usado onabet v1 todos os confrontos eliminatórios foi onabet v1 2011.

O objetivo do formato é proteger os jogadores contra a fadiga – com muitas estrelas do torneio tendo recentemente concluído longas e exaustivas temporadas onabet v1 clubes – e preservar a qualidade do futebol no torneio. Este ano, o campeonato foi disputado onabet v1 calor e a eliminação do tempo extra ajudou a preservar jogadores (e torcedores) de 30 minutos de jogo cansativo, indo diretamente para a emoção de uma disputa de pênaltis.

## Carga de trabalho dos jogadores de elite

Os jogadores de elite estão carregando uma carga de trabalho maior e mais intensa do que ``less jamais antes. O meio-campista do Uruguai Federico Valverde jogou 52 jogos na campanha vitoriosa da La Liga e Liga dos Campeões do Real Madrid na temporada 2024-24 da Europa, acumulando 4.280 minutos. Em comparação, seu novo companheiro de clube Kylian Mbappé estava abaixo do padrão na Euros por suas 48 e 3.869 minutos de ação pelo Paris Saint-Germain e foi substituído durante o período extra do jogo das quartas de final da França contra Portugal.

A carga de trabalho continuará a subir. A reformulação da Liga dos Campeões pela Uefa significa que os clubes jogarão dois jogos a mais na competição na temporada seguinte. Também há uma disputa onabet v1 andamento entre a Fifa e a associação internacional de jogadores sobre um torneio da Copa do Mundo dos Clubes expandido, que será realizado nos EUA onabet v1 2025, o que colocará uma carga adicional sobre os jogadores.

A esquivada da Conmebol ao tempo extra é pelo menos uma concessão menor para aliviar a carga crescente colocada sobre jogadores de alto nível, mesmo que venha à custa de um maior grau de aleatoriedade onabet v1 jogos eliminatórios decididos por disputas de pênaltis.

A ideia de descartar o tempo extra para ganhar alguns minutos tem pelo menos um defensor influente na Europa.

"Em um torneio desafiador como a Euro, talvez o tempo extra possa ser abolido", disse Luis de la Fuente, treinador da finalista da Euro 2024 Espanha, dizendo que o tempo extra deveria estar onabet v1 vigor apenas nas semifinais e final.

Nas fases eliminatórias do último-16 e quartas de final desta edição do torneio, cinco jogos estavam empatados após 90 minutos. Apenas dois gols foram marcados nesses cinco períodos extras, com a Inglaterra superando a Eslováquia e a Espanha derrotando a Alemanha. Três dos confrontos foram decididos por pênaltis.

Voltando à Euro 2000, foram jogados 29 períodos de tempo extra nos jogos eliminatórios do torneio. Nesses 30 minutos extras de jogo adicional, apenas 16 gols foram marcados. E, considerando que alguns dos períodos incluíram múltiplos gols, apenas 13 dos períodos extras incluíram ao menos um gol. Dos 29 jogos com períodos extras, 17 ainda foram decididos por pênaltis.

Os Euros anteriormente incluíram uma inovação interessante para limitar a necessidade de pênaltis no meio-final dos anos 90 e início dos anos 2000. Primeiro, houve o 'gol de ouro', que foi substituído pela regra do 'gol de prata' onabet v1 2004.

Sob a regra do gol de ouro, qualquer gol marcado no tempo extra encerrava automaticamente o

jogo, com a equipe ``
