Marle Cordeiro Files Lawsuit Against Mike Postle Seeking R\$250K

Over the weekend, Marle Cordeiro filed a lawsuit against Mike Postle, a story reported on by TMZ.

In a copy of the Complaint and Demand for

Trial by Jury obtained by PokerNews, Cordeiro seeks R\$250,000 in punitive damages as well as any other relief as may be just and proper. She has also requested a trial by jury.

Cordeiro is being represented by noted gaming attorney Maurice “Mac” VerStandig, who is also spearheading a separate, high-profile lawsuit against Postle and Stone’s Gambling Hall.

“The actions of Mike Postle offend not merely the standards of honor and decency that have long guided the poker world but, too, the law,” VerStandig told PokerNews when reached for comment. “We look forward to pursuing Ms. Cordeiro’s case in court and have faith in the judicial system.”

God Mode

The latest complaint, which was

filed in United States District Court District of Nevada, echoes many of the allegations laid out in the class action suit, namely that during live-streamed cash games someone sent Postle information regarding the competition’s hole cards, which Postle viewed on a cell phone placed in his lap.

“To carry out this pattern and

practice, Mr. Postle was aided by one or more confederates – defendants who will be joined in this litigation once their identities are learned through discovery – who furnished him with this information, for purposes of carrying out a fraud, through one or more concealed communicative mechanisms,” the lawsuit states.

If true, such

information would have granted Postle the ability to either win or mitigate loss in every hand. In the UltimateBet cheating scandal involving Russ Hamilton, this ability was deemed “God Mode,” which was referenced in a roundabout way in the latest lawsuit.

“Mr. Postle’s winnings on the Stones Live Poker broadcast, and his correlative play of poker, were so exceptionally outstanding as to lead the games’ commentators to

note his seemingly mystical abilities on numerous occasions, and to lead Stones Live Poker to produce various graphics portraying Mr. Postle as a deity-like individual imbued with omniscient powers (with one such graphic conflating an image of Mr. Postle and an image of Jesus Christ)."

The complaint continued: "This optimal decision making was so precise as to allow Mr. Postle to record net winnings in more than ninety four percent (94%) of the Stones Live Poker games in which he played from July 18, 2024 onward, even though such games are of fixed duration and elevated variance (relative to "normal" poker games); such a winning percentage, under these confined circumstances in a streamed environment, is not known to have ever been achieved by any other poker player – professional or amateur – over such a significant period of time."

How Does

Cordeiro Fit In?

Cordeiro is a well-known poker vlogger and co-host of The Rake Poker Podcast. In late 2024, she was invited to be a part of the Stones Live Poker broadcast playing R\$10/\$25/\$50 no-limit hold'em in a game involving Postle.

The lawsuit contends:

"Ms. Cordeiro makes her allegation of Mr. Postle systematically, habitually and regularly cheating at Stones Live Poker games based not on a hunch or suspicion but, rather, based on a statistical analysis of his results, analytical review of the manner in which he played, and extensive footage of his placing his cellular telephone between his legs and thereafter gazing at it when needing to make certain game-optimal decisions."

As evidence, the complaint highlights one hand played on the stream in which Cordeiro raised to R\$150 holding the Q10 and Postle called with the QJ from the big blind. The 9J8 flop gave Postle top pair and Cordeiro the nut straight.

Cordeiro bet R\$200 and Postle called to see the 4 on the turn. Cordeiro bet again, this time R\$600, and Postle folded.

"In a vacuum, this could be attributed to the Defendant having a conservative demeanor, having a quality 'read' on Ms. Cordeiro, or being exhausted at the end of a long night of poker; in the context of his fraudulent cheating operation, and realizing he was playing with the illicit advantage of knowing Ms. Cordeiro's Hole Cards, this is only attributable to his tortious conduct."

The

lawsuit then says that in "an honest game," Cordeiro could have expected to "have profited several thousand dollars" on this hand.

Did Postle Give It Away?

Cordeiro also

references one specific incident from May 6, 2024, in which she believes Postle inadvertently admitted to being aware of other players' hole cards. According to her, when he visited the commentary booth to discuss his pot-limit Omaha play, he let slip information that revealed his scheme when he asked, "So what happened on that PLO hand where it only showed two of our cards?"

"[He] indicated he was aware that a specific hand's broadcast had only displayed 'two of our cards' to the viewing public (whereas four cards should have been displayed, based on the type of poker being played), even though he would not have had the opportunity to view the broadcast – and, thus, become aware of this technical malfunction – prior to making that comment, unless he had illicitly accessed the information in real time, with the aid of one or more confederates."

In other words, Cordeiro contends there's no way Postle could have known two of the hole cards didn't show up unless he was in fact cheating by viewing the RFID table's feed.

She goes on to say that in the rare instances when Postle did lose on the stream, he did not stare at his lap and such sessions appeared to coincide when “the person suspected of being his chief confederate was absent from the Sacramento area.”

Postle has not responded to PokerNews' request for comment at the time of publication.

After he is officially served, Postle will have 21 days to provide an answer to the complaint against him. If he fails to do so, a judgment by default could be entered against him.

Shohei Ohtani se acerca a la historia de la MLB con jonrón y robo de base

Shohei Ohtani se acercó aún más a la historia de la MLB el miércoles por la noche, ya que conectó su 47º jonrón y su 48º robo de base de la temporada en su intento de lograr la primera temporada de 50-50 en la historia de la liga.

La estrella de dos veces MVP de la Liga Americana tuvo un gran juego, bateando 2-de-4 con tres carreras impulsadas y un boleto para ayudar a los Dodgers de Los Ángeles a evitar una barrida en una emocionante victoria por 10-8 sobre los Cachorros de Chicago.

Ohtani está haciendo historia casi en cada juego en este momento y ahora ha superado su propio récord personal de jonrones en una temporada, habiendo conectado 46 para los Angelinos de Los Ángeles en 2024. La estrella japonesa ahora está solo a dos jonrones de igualar el récord de franquicia de los Dodgers de 49 jonrones conectados por Shawn Green en 2001.

El más cercano que ha estado al récord de 50-50 de 50 jonrones y 50 robos han sido Ronald Acuña Jr. de los Bravos de Atlanta, quien robó 73 bases y conectó 41 jonrones en 2024, y Alex Rodríguez, quien como miembro de los Marineros de Seattle conectó 42 jonrones y robó 46 bases en 1998.

Reacciones de los entrenadores y compañeros de equipo

"Para que bata la pelota a 118 mph en ese ángulo, normalmente es un doble", dijo el manager de los Dodgers, Dave Roberts, según MLB.com. "Pero para Shohei, es un jonrón. Está jugando un gran béisbol. Puedes ver que nos está levantando big time".

El compañero de equipo de Ohtani, Max Muncy, fue igual de elogioso en sus alabanzas. "Es increíble", dijo el tercera base, según MLB.com. "Cada noche, siento que hace algo que nunca hemos visto. Esta noche, golpea una pelota a 118 [mph]. Siento lástima por el fanático que intentó atraparlo. Todo lo que hace es tan impresionante, así que es divertido ser parte de eso".

Resumen del juego

Los Cachorros comenzaron bien su intento de barrer la serie, tomando una ventaja de 2-0 en la parte superior de la primera. Pero los Dodgers respondieron con cinco carreras en la parte inferior de la primera, dando vuelta al juego de inmediato.

Ohtani, por supuesto, fue el primero, sacudiendo su jonrón al campo central derecho. Después de dos outs, Tommy Edman continuó su forma impresionante con un jonrón de dos carreras a campo izquierdo para dar a los Dodgers la delantera.

Los Dodgers no estaban satisfechos allí. Next up fue Will Smith, quien conectó un jonrón casi idéntico para hacer que fuera 4-2, antes de que Muncy se uniera a la fiesta con su propio jonrón. Solo ha ocurrido siete veces en la historia de los Dodgers que han conectado cuatro jonrones en una entrada, y el jonrón de Muncy significó que los Dodgers son el primer equipo en conectar jonrones consecutivos en el primer inning de múltiples juegos en una temporada desde los Bravos en 1994.

El jonrón robado de Ohtani llegó en la segunda, antes de una entrada en la que Seiya Suzuki conectó un jonrón solitario para reducir la ventaja de los Dodgers a dos, pero un sencillo de dos carreras de Ohtani abrió la brecha nuevamente a 7-3.

Una quinta entrada impresionante para los Cachorros vio el jonrón de tres carreras de Cody Bellinger y el sencillo remolcador de Pete Crow-Armstrong empatar el juego a 7-7, pero los Dodgers respondieron con un sencillo remolcador de Gavin Lux en la séptima y otro jonrón de dos carreras de Edman en la octava — marcando juegos consecutivos con dos jonrones para el jardinero central.

Con el juego en 10-7, los Cachorros no pudieron montar otra remontada, el elevado de sacrificio de Isaac Paredes en la novena fue la última acción significativa de un excelente juego.

Ohtani ahora tiene 16 juegos restantes en la temporada regular para encontrar los tres jonrones y dos robos necesarios, comenzando el viernes contra los Bravos.
