**A medida que as águas poluídas começam a cobrir as cabeças do Torydom, os seus criadores de pensamento na Rua Tufton tocam canções desafinadas como a orquestra no Titanic.**

Em três lindas casas de Westminster, moram a Aliança dos Contribuintes, o Instituto de Assuntos Econômicos, o Migration Watch UK, a Fundação Global de Políticas de Aquecimento Global, a Fundação Europeia, o Centro de Estudos de Políticas fundado pela Margaret Thatcher (CPS) e outros, todos muito vagos sobre suas fontes de financiamento. Agora, eles afundam juntos,



continuando a tocar as músicas antigas fora de sintonia com o país, do qual parecem não saber nada.

Fui assistir à apresentação de um relatório do CPS na quarta-feira, enquanto eles chamavam mais uma vez para a diminuição do estado através da desregulamentação. Esperava até o fim, mas não, não havia uma única linha, nem uma menção saque recusado onabet seu relatório sobre falhas regulatórias recentes. Nada sobre as falhas da Ofwat na permissão de empresas de água para despejar esgoto saque recusado onabet rios e mares.
