# Canadá Post registra prejuízo operacional de 221 milhões de dólares canadenses no primeiro trimestre de 2024

A Canada Post encerrou a semana com mais notícias financeiras desanimadoras, anunciando uma perda operacional de 221 milhões de dólares canadenses nos primeiros três meses do ano. Isso se soma à perda de 748 milhões de dólares canadenses anunciada no início do mês, relacionada ao resultado do ano passado.

A empresa postal controlada pelo governo acumulou mais de 3 bilhões de dólares app de cassino dinheiro real prejuízos desde 2024 e ofereceu um panorama sombrio para os próximos anos no relatório anual de 2024, divulgado este mês.

"Prevemos perdas maiores e cada vez mais insustentáveis nos próximos anos", escreveu a empresa, acrescentando que, sem emprestar outros 1 bilhão de dólares e refinanciar 500 milhões de dólares app de cassino dinheiro real dívida atual, esgotará app de cassino dinheiro real caixa no início do próximo ano.

## Crise financeira ameaça o papel da Canada Post como infraestrutura nacional

"A Canada Post está app de cassino dinheiro real um ponto crítico app de cassino dinheiro real app de cassino dinheiro real história", escreveu a empresa com franqueza incomum app de cassino dinheiro real relatórios anuais. Além das empresas sindicalizadas como a UPS Canada, que têm uma estrutura de custos semelhante, a Canada Post agora enfrenta um número crescente de pequenas empresas que dependem de trabalhadores mal pagos, que não recebem benefícios.

Antes da pandemia, a Canada Post entregou 62% de todas as encomendas no Canadá. Agora, ela lida com apenas 29%.
