[1] Geralmente, a corrupção ocorre por meio de recursos dos orçamentos públicos da União, dos Estados e dos Municípios destinados à saúde, à educação, à previdência e à programas sociais e de infraestrutura, que são desviados para financiar campanhas eleitorais, corromper funcionários públicos, ou mesmo para contas bancárias pessoais no exterior.

Em 13 de outubro de 2020, a Transparência Internacional apontou uma "progressiva deterioração do arcabouço institucional anticorrupção no país" e sérios retrocessos no combate a corrupção no Brasil.[2][3]

Uma forma de corrupção comum no Brasil é o desvio de fundos públicos por meio de superfaturamento.

Essa técnica permite que o indivíduo se enriqueça e também financie campanhas políticas e está intimamente ligada aos contratos públicos com empresas privadas.

Brazilian regional television network

RBS TV is a Southern Brazilian television network owned by Grupo RBS, and one of the oldest 4 Rede Globo affiliates.

The acronym originally stood for Rede Brasil Sul de Televisão (English: "Brazil South Television Network"), but currently the 4 network never uses its full name on-air.

RBS TV owns 12 television stations in Rio Grande do Sul.

RBS TV Porto Alegre 4 is the headquarters for the network.

RBS TV stations produce an average amount of local and regional programming, composed mainly of 4 news, but also drama series, documentaries, sports, variety and youth programming.

History [edit]

TV Gaúcha was created in 1962 in Porto Alegre, Rio Grande do Sul, 4 and would later become RBS TV Porto Alegre.

The following year, TV Gaúcha affiliated itself with Rede Excelsior.

Rede Globo was launched 4 in Rio de Janeiro two years later, but TV Gaúcha would only become its affiliate in 1967.

In 1979, it started 4 to operate in Florianópolis, the capital city of Santa Catarina.

This new purchase obliged the network to change its name to 4 something less Rio Grande do Sul-related (as the word "Gaúcha" was), and it was rebranded RBS TV that same year.

Inquiry on RBS Group oligopoly / monopoly 4 practicing [edit]

The RBS Group is being investigated by the practice of oligopoly / monopoly.

In 2008, the Federal Prosecutor 4 of Santa Catarina has filed a public civil action (Case No..2008.72.00.

014043-5) against the company oligopoly Rede Brasil Sul (RBS) in 4 southern Brazil.

The MPF requires the company, among other measures, to reducing its number of TV and radion stations in the 4 states of Santa Catarina (SC) and Rio Grande do Sul (RS), so that to be in according to the Brazilian 4 law; and the cancellation of the purchase of the newspaper A Notícia from Joinville, consummated in 2006 - which resulted 4 in a virtual monopoly over the relevant newspapers in the state of Santa Catarina.[1]

In 2009, the Federal Prosecutor in Canoas 4 (RS), Pedro Antonio Roso, asked the chairman of the RBS Group, Nelson Pacheco Sirotsky, among other informations, the number of 4 TV and radio stations that the company owns in Rio Grande do Sul, "as well as its affiliates, stations and 4 repeaters.

" The request is part of an administrative proceeding brought by federal prosecutors "to determine possible occurrence of monopolistic practices 4 and irregularities in granting Radio and Television to the RBS Group in Rio Grande do Sul".[2]
