I have a sizable

chunk of money on bwin.be (the Belgian skin of partypoker), in USD. My account has been funded with my Skrill account in EUR, but if I would cash out to that account I'd lose

~2k USD in conversion fees. I also have a Skrill account in USD, that I have been able

to use for additional deposits (without any issues), and for which I wouldn't have to pay conversion fees on my cashouts. I have been trying to cash out to this USD account

since the beginning of July, but with every attempt there was some kind of problem

(they charge double conversion fees because of an 'error in their system' or a 'human error', they think my Skrill USD account is in EUR, ...). Their latest info was that my

cashout in USD was cancelled because 'my moneybookers is in EUR' (even though I cashed out to my Skrill USD account). I replied that that statement was incorrect on August

13th and I have yet to receive a reply. I sent 3 reminders (last one earlier today) and

PM'd the party_rep on this forum but have yet to receive a reply, and have no idea how

I can make a successful cashout at the moment. The details (mostly a bunch of e-mails and some info regarding cashouts) are kinda boring but I'll provide them for completeness

sake. I bolded some relevant stuff in their e-mails. successful cashout to my Skrill

account in EUR (but with conversion charges) successful deposit with my Skrill USD

account withdrawal to my Skrill USD account for which I had to pay 2x conversion fees

(USD -> EUR on bwin and then EUR -> USD on Skrill) mail from support explaining how to

deactivate my Skrill EUR account and activate my Skrill USD account (even though the deposit and withdrawal from July 7th didn't require 'registration' although maybe the

fact that the account hadn't been registered yet could have caused the double

conversion fees)I gave them the required info and they confirmed I could now use my Skrill USD account:I referred to my cashout from July 7th for which I had to pay the double conversion fees, to which they replied:I do what they ask and try another small cashout. This one again leads to double conversion fees. When I ask them what's wrong, this is their reply:They confirm everything is OK now and I can try cashing out a bigger amount:Unfortunately this cashout didn't materialize:So apparently the earlier deposit from my Skrill USD account (July 7th) wasn't registered or something. My reply:I receive another mail saying that everything should be OK now:I try to cashout to my Skrill USD again and receive the following mail on August 13th:So even though I cashed out to my Skrill USD account, they somehow think it's a EUR account. I explain them this on August 13th:I have not received a reply to this mail yet, at the moment have no idea how I should do a cashout, and have gone from 'slightly irritated' about this whole process to 'very tilted' and somewhat worried they won't let me cash out my money.

La mayoría de las áreas marinas protegidas de Europa no cumplirán los objetivos de conservación

La mayoría de las áreas marinas protegidas (AMP) de Europa, creadas para salvaguardar especies y hábitats, no cumplirán los objetivos de conservación, ya que ofrecen solo una "protección marginal" contra actividades industriales como dragado, minería y arrastre de fondo, según un estudio.

Niveles de protección bajos en el 86% de las AMP han dejado a la UE lejos de alcanzar sus objetivos de biodiversidad de 2030, que están diseñados para reducir el riesgo de extinción de las especies, según los investigadores en un artículo publicado en la revista One Earth. La UE tiene como objetivo proteger el 30% de sus mares para 2030, con el 10% "estrictamente" protegido de actividades dañinas.

"Es la primera evaluación de dónde estamos en términos de protección", dijo Juliette Aminian-Biquet, autora principal del artículo, investigadora en la Universidad de Algarve, centro de ciencias marinas de Portugal. "Esto muestra que estamos al principio de proteger nuestros océanos". El artículo concluyó que alcanzar la meta del 10% de protección estricta de la UE requerirá "cambios radicales" en la regulación de las actividades en sus santuarios marinos.

La cobertura más alta de santuarios marinos en la UE fue en Alemania (45% de las aguas nacionales), con Francia y Bélgica no lejos.

Los niveles más altos de "protección fuerte", también definidos como áreas altamente o completamente protegidas, por ejemplo, santuarios que no permiten actividades extractivas o pesca ocasional, se encontraron en el Mar Mediterráneo y el Mar Báltico. El país europeo que mejor se desempeña en mantener la actividad destructiva a raya en sus áreas protegidas es Eslovenia, aunque el número total de AMP que tiene en sus aguas es relativamente bajo en comparación con otros países, según el informe.

Bajos niveles de protección

Los bajos niveles de protección en la mayoría de las AMP son el resultado de la "flexibilidad" de las directivas de la UE, encontraron los investigadores. "Para que las AMP proporcionen los beneficios sociales y ecológicos esperados, su papel en la regulación de las actividades humanas para limitar sus impactos negativos debe cuestionarse", dijeron los autores.

"Lograr que la UE haga algo sobre este tema es extremadamente difícil, ya que la regulación debería ser legalmente vinculante", dijo Aminian-Biquet. "Va a ser responsabilidad de los estados individuales o las autoridades regionales tomar medidas para cumplir estas metas".

Un portavoz de la Comisión Europea dijo: "La Comisión tiene en cuenta la muy reciente publicación y sus hallazgos clave en resumen", y dijo que había pedido a los estados miembros que administren todas las AMP de acuerdo con las directivas relevantes y los compromisos de la UE de proteger el 30% de las áreas marinas y costeras para 2030. Agregaron que el plan de acción marina de la UE de 2024 recomendó a los estados miembros eliminar el arrastre de fondo en las AMP para 2030.

La eliminación fue rechazada por el Parlamento Europeo en enero y la mayoría de los estados de la UE no han establecido aún medidas sobre el arrastre de fondo, con la excepción de Grecia, que se convirtió en el primer país en prohibir el arrastre de fondo en las AMP este año, y Suecia.
