O que é a Onabet?

A Onabet é uma pomada contendo 2% de Onabe, um medicamento antifúngico usado para tratar infecções fúngicas da pele nos pés e entre os dedos do pé, também conhecidas como tinea pedis ou "pé de atleta". A Onabet atua matando o fungo causador do problema.
