Information We Collect2.

1 Information You Provide Us.

You can provide information to us through various means using our Digital Properties.

We collect both personal information, which is information that identifies you as an individual or relates to an identifiable individual, and non-personal information.

The information we collect may include the following:NameHome address

Home / mobile telephone numberEmail addressGenderHeight and weightDate of birth

Credit, debit or other payment account number and related information and employment verification

Social media account ID

For corporate sponsored program participants: Name of Employer

For health insurance related program participants: Insurance Information

For school-related programs: name of School or Group

During the My24 online account creation process, you will select a user name and password.

If you purchase any products or services through our Digital Properties, we or our payment processors collect your credit card or debit card number and related information, as applicable.

We collect information from you when you purchase a membership and other services from us, including when you use the 24GO mobile app to purchase a membership and/or access other services.

If you sign up for a free day pass to our clubs, you will provide us with certain information, such as your name, email address, telephone number, and birthdate.

If you use certain of our mobile applications, we will collect information about any fitness devices that you choose to connect to the application, such as sensors and wearable devices, as well as the activity and other information collected through any such fitness devices.

In addition, if you choose to add a third-party fitness data platform to the 24GO mobile application (such as Apple Health, Google Fit, or Fitbit), we will collect information from any such platform.

Such information may include, for example, body measurements and activity types and data (e.g. , steps, heart rate, distance, speed, sleep).

You may revoke your consent to such sharing by accessing the settings for the relevant platform.

If you choose to connect your social media account to your Digital Properties account, certain personal information from your social media account will be shared with us, which may include personal information that is part of your profile or your friends' profiles.

You may revoke your consent to have the social media platform share information with us by changing your settings within such platform.2.

2 Log Information We Collect from You Automatically.

We collect certain information automatically as you use our Digital Properties, including your IP (Internet Protocol) address, browser type, computer type, type of mobile device (if used), the carrier for your mobile device, your computer operating system, the version of the Digital Properties that you access, the site from where you navigated to our Digital Properties, the time and date of using the Digital Properties, whether you are a repeat visitor, how long you use the Digital Properties and the pages that you view.

We may derive your approximate location from your IP address.2.3 App Usage Data.

When you download and use any of our mobile applications, we and our service providers may track and collect app usage data, such as the date and time the app on your device accesses our servers.2.4 Cookies.

When you visit or use our Digital Properties, we send one or more "cookies" to your computer or other device.

A cookie is a small file containing a string of characters that is sent to your computer when you visit a website.

When you visit the website again, the cookie allows that site to recognize your browser.

Cookies may store unique identifiers, user preferences and other information.

You may opt-out of most cookies through available links on our site and as described in Section

4.2.

You can also reset your browser to refuse or restrict most cookies or to indicate when a cookie is being sent.

However, some website features or services may not function properly without cookies.

Cookie based opt-outs must be performed on each device and browser that you wish to have opted-out.

You must separately opt out in each browser on each device.

We use cookies to improve the quality of our service, including for storing user preferences, tracking user trends and providing relevant advertising to you based on your activities on the Digital Properties and on other websites.

At this time, we do not respond to browser 'do not track' signals.

2.5 Pixel Tags.

We may use "pixel tags," which are small graphic files that allow us to monitor the use of our websites.

A pixel tag can collect information such as the IP address of the computer that downloaded the page on which the tag appears; the URL of the page on which the pixel tag appears; the time the page containing the pixel tag was viewed; the type of browser that fetched the pixel tag; and the identification number of any cookie on the computer previously placed by that server.

When corresponding with you via HTML capable email, we may use "format sensing" technology, which allows pixel tags to let us know whether you received and opened our email.

We use Google Analytics, which uses cookies and similar technologies to collect and analyze information about use of the Digital Properties and report on activities and trends.

This service may also collect information regarding the use of other websites, apps and online resources.

6 Physical Location.

We may collect the physical location of your device by, for example, using satellite, cell phone tower, or WiFi signals.

We may use your device's physical location to provide you with location-based services and content and to learn when you have checked into one of our clubs.

We may also share your device's physical location, combined with information about what advertisements you viewed and other information we collect, with our marketing service providers to enable them to provide you with more localized content and to study the effectiveness of advertising campaigns.

You may be able to allow or deny such uses and/or sharing of your device's location by changing your device's location settings, but if you choose to deny such uses and/or sharing, we and our marketing service providers may not be able to provide you with the location-based services and content.

2.7 Other Sources.

We may receive information about you from other sources, such as public databases, commercially available sources, service providers, advisors and agents, advertising networks, data analytics providers, internet service providers, operating systems and platforms, social networks, employers, government entities and other third parties, including via referrals from other members or guests or in connection with purchases of any "Add-On" memberships that include you as a member.

8 Aggregated Information.

We may aggregate or deidentify personal information.

Aggregated or deidentified information does not identify and is not associated with you or any other user of our Digital Properties.

8 Verification Information.

In connection with the COVID-19 pandemic, and in conjunction with federal, state and local requirements, 24 Hour Fitness may screen and collect certain information from members and

guests, including verification of vaccinated status or a pre-entry negative test result, where permitted or required, as part of the club check-in process ("Verification Information").

Access to certain 24 Hour Fitness clubs is currently limited to individuals who can provide a verification of vaccinated status or a pre-entry negative test result.

We will check your Verification Information when you check in, but we will not make a copy of the Verification Information, itself.

If you prefer not to have 24 Hour Fitness indicate in our systems that you have provided your Verification Information, you will need to bring your Verification Information each time you visit a club.

Any Verification Information indications that we retain will be stored for a reasonable period of time, including as we determine necessary to comply with applicable law or to establish or defend our legal rights.

Please note that options for providing Verification Information vary by jurisdiction based on federal, state and local requirements and may change from time to time.³

How We Use Your Information³.

1 To Provide Products, Services, and Information.

As described above, we collect information from you so that we can provide products and services that you purchase or otherwise request using the Digital Properties and information that you request from us.

For example, we use your personal information to:

Set-up your membership

Provide services and products to you

Process payments for your membership and services, including credit card, debit card and bank account debit (ACH) transactions

Contact you regarding your membership and services, and other administrative information

Track member and guest use of our facilities

Respond to your inquiries, comments, reviews and ratings³.

2 Marketing Emails We may use your information to send you marketing communications that we believe may be of interest to you.

You can always opt-out of receiving marketing emails by using the opt-out feature provided with the email communications.³

5 Our Business Purposes.

We may use your information for our business purposes, such as data analysis, research, audits, fraud monitoring and prevention, developing new products and services, enhancing, improving or modifying our Digital Properties, identifying usage trends, determining the effectiveness of our promotional campaigns and operating and expanding our business activities.³

3.6 Other Purposes. We may use non-personal information for any purpose, except where we are required to do otherwise under applicable law.

In some instances, we may combine non-personally identifiable information with personal information (such as associating your name with your employer if you are a participant in a corporate sponsored program), in which case we will treat the combined information as personal information as long as it is combined.⁴

How We Share Your Information⁴.

1 Our Third Party Service Providers.

We may share your information with our third party service providers and agents who provide services such as website hosting, data analysis, order fulfillment, information technology and related infrastructure provision, customer service, email delivery, text messaging, credit card or other payment processing, auditing and similar services.⁴

2 Advertising and Third Party Advertisers.

We may use third-party advertising companies to serve advertisements regarding goods and services that may be of interest to you when you access and use our Clubs, our Digital Properties and other websites and online services, based on information relating to your access to and use of our Digital Properties and other websites and online services on any of your devices, as well as

on information received from you both online and offline and from third parties.

To do so, these companies may place or recognize a unique cookie on your browser (including through the use of pixel tags), and they may also use the information to measure the effectiveness of ads.

In addition, they may use these technologies, along with information they collect about your online use, to recognize you across the devices you use, such as a mobile phone and a laptop.

We may share Digital Properties usage and other information with third party advertisers and partners for the purpose of effectively targeting our online advertisements unless you opt-out.

Please note that California consumers can opt-out of the "sale" of their personal information under the California Consumer Privacy Act as described in Section 8.

3 Legal Requests or Requirements and to Prevent Harm.

We reserve the right to disclose your personal information as required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process.

We may also share personal information when we have a good faith belief it is necessary to prevent fraud or other illegal activity, to prevent imminent bodily harm, or to prevent harm to or protect the rights or property of, 24 Hour Fitness, the Digital Properties, our members or others.

This may include sharing information with other companies, lawyers, courts, or other government entities.^{4.4} Sharing by You.

If you post comments, information or other materials on our message boards, blogs, social media pages or other services, please note that any information you post or disclose through these services will become public information and may be available to users of the Digital Properties and to the general public.

We urge you to be very careful when deciding to disclose your personal information, or any other information, on the Digital Properties.

If you are a resident of California, under 18 and a registered user of the Digital Properties, you may ask us to remove content or information that you have posted to the Digital Properties by writing to cpm24hourfit.com.

Please note that your request does not ensure complete or comprehensive removal of the content or information, as, for example, some of your content may have been reposted by another user. In addition, we may share information about you and your fitness activities, progress and goals with your personal trainer, research organization or other individual or entity you designate, if you choose to permit such sharing.⁴

5 Sharing with Other Services.

If you choose to connect our mobile application to a third-party fitness data platform (such as Apple Health, Google Fit, or Fitbit), we will share your information with such platform, which may have information practices that are different from ours.

You may revoke your consent to such sharing by accessing the settings for the relevant platform.

Similarly, if you elect to connect your social media account to your Digital Properties account,

your personal information may be shared with your friends associated with your social media account and with your social media account provider (which may have different information practices from ours).

You may change your preferences by accessing the social media platform's settings.⁴

6 Transfer in the Event of Sale or Change of Control.

If the ownership of all or substantially all of our business changes or we otherwise transfer assets relating to our business or the Digital Properties to a third party, we may transfer your personal information to the new owner.⁴

7 Other Sharing of Non-Personally Identifiable Information.

We seek to use industry standard physical, technical and administrative security measures designed to protect your personally identifiable information.

However, no data transmission or storage system can be guaranteed to be 100% secure.

If you have reason to believe that your interaction with us is no longer secure (for example, if you feel that the security of any account you might have with us has been compromised), please immediately notify us in accordance with the "Questions" section above.

You should take steps to protect against unauthorized access to your password, phone, and computer by, among other things, signing off after using a shared computer, choosing a robust password that nobody else knows or can easily guess, and keeping your log-in and password private.

We are not responsible for any lost, stolen, or compromised passwords or for any activity on your account via unauthorized password activity.⁷

Changes to Our Privacy Policy

If we decide to change our Privacy Policy, we will post those changes to the Privacy Policy on this page, and other places we deem appropriate so that you are aware of what information we collect, how we use it, and under what circumstances we disclose it.

Important Additional Information for California Residents

This section of our Privacy Policy includes information for California residents, as required under California privacy laws, including the California Consumer Privacy Act ("CCPA").

California privacy laws require that we provide California residents information about how we use

California Residents' Rights

California law grants California residents certain rights and imposes restrictions on particular business practices as set forth below.

Right to Opt-In. We do not sell personal information about residents who we know are younger than 16 years old without opt-in consent.

Notice at Collection.

We are required to notify California residents, at or before the point of collection of their personal information, the categories of personal information collected and the purposes for which such information is used.

Verifiable Requests to Delete, and Requests to Know.

Subject to certain exceptions, California residents have the right to make the following requests, at no charge, up to twice every 12 months:

Right of Deletion: California residents have the right to request deletion of their personal information that we have collected about them, subject to certain exemptions, and to have such personal information deleted, except where necessary for any of a list of exempt purposes.

Right to Know – Right to a Copy: California residents have the right to request a copy of the specific pieces of personal information that we have collected about them in the prior 12 months and to have this delivered, free of charge, either (a) by mail or (b) electronically in a portable and, to the extent technically feasible, readily useable format that allows the individual to transmit this information to another entity without hindrance.

Right to Know – Right to Information: California residents have the right to request that we provide them certain information about how we have handled their personal information in the prior 12 months, including the:

categories of personal information collected;

categories of sources of personal information;

business and/or commercial purposes for collecting and selling their personal information;

categories of third parties/with whom we have disclosed or shared their personal information;

categories of personal information that we have disclosed or shared with a third party for a business purpose;

categories of personal information collected; and

categories of third parties to whom the residents' personal information has been sold and the specific categories of personal information sold to each category of third party.

Submitting Requests.

For those with a My24 account, log into your account on the 24 Hour Fitness website, go to the Personal Information page and click on the "California Privacy Rights" and follow instructions.

Requests to exercise these rights may be submitted by clicking Do Not Sell My Personal Information, contacting us at via email at ccpadr24hourfit.com or via (800) 432-6348 (toll free).

We will respond to verifiable requests received from California consumers or authorized agents as required by law.

When you submit a request to know or a request to delete, we will take steps to verify your request by matching the information provided by you with the information we have in our records.

In some cases, we may request additional information in order to verify your request or where necessary to process your request.

If we are unable to adequately verify a request, we will notify the requester.

Authorized agents may initiate a request on behalf of a California individual (and we may confirm this request with the individual), and authorized agents will be required to provide proof of their authorization as permitted by applicable law.

Right to Non-Discrimination, and Incentives.

The CCPA prohibits discrimination against California residents for exercising their rights under the CCPA and imposes requirements on any financial incentives offered to California residents related to their personal information.

We do not currently offer any financial incentive programs.

Categories of Personal Information.

The table below identifies the categories of personal information (as defined by the CCPA) we have collected about consumers in the past 12 months.

Categories **Description** **Identifiers** Includes direct identifiers, such as name, alias user ID, username, account number or unique personal identifier; email address, phone number, address and other contact information; IP address and other online identifiers; and other similar identifiers.

Customer Records Includes personal information, such as name, account name, user ID, contact information, employer, account number, and financial or payment information, that individuals provide us in order to purchase or obtain our products and services.

For example, this may include information collected when an individual register for an account, purchases or orders our products and services, or enters into an agreement with us related to our products and services.

Commercial Information Includes records of products or services purchased, obtained, or considered, or other purchasing or use histories or tendencies.

For example, this may include demographic information that we receive from third parties in order to better understand and reach our customers.

Usage Data Includes browsing history, clickstream data, search history, access logs and other usage data and information regarding an individual's interaction with our websites, mobile apps and other services, and our marketing emails and online ads.

Geolocation Data Includes location information about a particular individual or device.

Audio, Video and Electronic Data Includes audio, electronic, visual, thermal, olfactory, or similar information such as, CCTV footage (e.g.

, collected from visitors to our facilities), photographs and images (e.g.

Professional information Includes professional and employment-related information (such as current and former employer(s) and position(s), business contact information).

For example, if your employer sponsors your membership plan.

Biometric information Physiological, biological or behavioral characteristics that can be used alone or in combination with each other to establish individual identity.

For example, if you chose to do so, we may use fingerprint scanners for fraud detection and authentication purposes when you enter our facilities.

Inferences Includes inferences drawn from other personal information that we collect to create a profile reflecting an individual's preferences, characteristics, predispositions, behavior, abilities or aptitudes.

For example, we may analyze personal information in order to identify the offers and information that may be most relevant to customers, so that we can better reach them with relevant offers and ads.

Purposes and Categories.

Please note that under the CCPA, a "sale" includes disclosing or making available personal information to a third-party in exchange for monetary compensation or other benefits or value. Sua avaliação é um aviso aos americanos de que Helene, o furacão mais mortal a atingir os EUA onabet suporte quase duas décadas foi raro mas não tem efeito. Depois de analisar Helene, uma equipe internacional dos cientistas estimou que a tempestade despejou 10 por cento mais chuva do mesmo modo extremo teria feito onabet suporte tempos frios. Como rugindo para terra firme seus ventos foram cerca 13 milhas / hora maior intensa e as águas oceânica da qual o furacão atraiu energia eram ao redor 2.3 graus Fahrenheit quente ndice 1 °C

Como todos os furacões mais destrutivos, Helene não foi apenas uma catástrofe meteorológica: onabet suporte devastação também reflete fatores como infraestrutura local e prontidão.

"Precisamos acelerar nossa preparação e adaptação para esse tipo de evento que está além do imaginável", disse Julie Arrighi, diretora dos programas no Centro Climático da Cruz Vermelha Vermelho Crescente (CIC) com um autor. Muitas das calamidades climáticas atuais estão "além daquilo a qual costumávamos considerar como uma ocasião única na vida", afirmou ela perante o jornal The Guardian onabet suporte comunicado à imprensa sobre as consequências desta catástrofe climática nos últimos anos."

O relatório sobre Helene foi produzido por quase duas dúzias de pesquisadores afiliados à World Weather Attribution, uma iniciativa liderada pelos cientistas do Imperial College London. Sua análise ainda não passou pela revisão acadêmica dos pares embora se baseie onabet suporte métodos que o grupo usou para estudar outros eventos climáticos extremos - inclusive revistas revisada- entre paristas

As descobertas sobre Helene se alinham com as previsões dos pesquisadores de como o clima quente pode estar afetando furacões e ciclones tropicais onabet suporte todo mundo.

Em todo o mundo, a proporção de tempestades que se torna muito intensas é projetada para aumentar à medida onabet suporte um aquecimento contínuo do planeta. De acordo com os dados da Administração Nacional Oceânica e Atmosférica (NOAA). Tempestade também são esperado ser mais propensos ao reunir força rapidamente como eles atravessam águas oceânica tépidamente quentes;

A superfície quente da banheira do Golfo de México no mês passado ajudou o furacão Helene a intensificar-se para Categoria 4, vindo das categorias 1 onabet suporte menos que um dia. Na segunda feira passada (horrúbrica), Milton chegou à categoria 5 com uma velocidade ainda maior ndice

Outra maneira de o aquecimento global estar afetando furacões é que ar mais quente pode absorver maior umidade do vento, permitindo tempestades cairem onabet suporte chuvas maiores. Helene efetivamente entregou duas grandes cargas úteis da chuva para a região sudeste", disse Jay Cordeira cientista atmosférico na Scripps Instituição of Oceanography (Sclipps).

Enquanto o centro do furacão ainda estava sobre a região central, os ventos da tempestade enviaram uma enorme quantidade de ar tropical úmido para norte. Essa onda caiu nas montanhas dos Apalaches e um vale com mais frio no Vale Rio Ohio causando fortes chuvas na Geórgia ou nos Appalachianos meridionais

O próprio furacão rugiu onabet suporte terra, trazendo ainda mais chuva. Dr Cordeira disse que a corrida de umidade anterior Helene se assemelhava um rio atmosférico ou uma longa e fina correia transportadora do ar transportando vapor d'água para fora dos trópicos...

Nos Estados Unidos, os rios atmosféricos são mais conhecidos por fornecer chuva e neve fortes para a Califórnia. Mas eles podem moldar o clima onabet suporte outros lugares também incluindo no Sudeste

"Este tipo de evento, não é sem precedentes", disse o Dr. Cordeira que se envolveu com a análise da World Weather Attribution's mas na onabet suporte localização e intensidade foi definitivamente inédito."

Ao examinar como a mudança climática afeta o clima extremo, os cientistas enfrentam vários desafios. Por definição eventos extremos não acontecem com frequência - dados meteorológicos para alguns lugares remontam menos de um século e as condições meteorológicas variam naturalmente muito; portanto pesquisadores precisam realizar análises cuidadosaes que possam influenciar mudanças extremas causadas pelo homem

A atribuição do tempo mundial faz isso usando modelos de computador para conduzir o que são

efetivamente experimentos sobre clima global. Por exemplo, como seria se os seres humanos não tivessem aquecido a atmosfera e oceanos? E qual é essa comparação com as condições climáticas da forma onabet suporte si mesmas?"

Para estudar o furacão Helene, os pesquisadores usaram modelos e observações meteorológicas para examinar picos de chuva onabet suporte dois dias ou três por duas regiões: Big Bend da Flórida (EUA).

Quando estimaram até que ponto as mudanças nesses picos poderiam ser atribuídas ao aquecimento causado pelo homem, nem todos os seus resultados foram estatisticamente significativos. Mesmo assim estudos anteriores de outros furacões e princípios bem estabelecidos da física deu aos pesquisadores "alta confiança" onabet suporte concluírem uma tempestade tão rara quanto Helene teria sido menos chuvoso no clima pré-industrial", escreveram dois dos autores do relatório Ben Clarkes and Friederike Otto num email. Os cientistas do clima estimaram agora a influência da Terra onabet suporte centenas de eventos climáticos severos no mundo todo. Eles podem produzir essas estimativas com sofisticação cada vez maior, o que levou alguns pesquisadores perguntarem se suas descobertas poderiam ajudar os governos determinar quanto países altamente poluentes devem compensar aqueles menos poluentes pelos danos causados pelo tempo extremo".

Alguns cientistas dizem que os estudos de atribuição das alterações climáticas ainda têm limitações significativas, particularmente quando se trata da tradução dos perigos como chuvas pesadas onabet suporte custos monetários.

Para Michael Wehner, cientista sênior do Laboratório Nacional Lawrence Berkeley. Nenhuma dessas limitações é disruptora de negócios: quando se trata da compensação por desastres "algumas informações são melhores que nenhuma informação", disse o Dr."

A outra arena onde a atribuição de mudanças climáticas está começando desempenhando um papel é o tribunal.

A organização sem fins lucrativos Our Children's Trust, do Oregon (O Nosso Fundo para as Crianças), usou a análise de atribuição onabet suporte dois casos bem-sucedido no Montana e Havaí que buscaram forçar ações governamentais com o objetivo da redução das emissões. Mas Julia Osson fundadora deste grupo disse: "A carga dos dados será maior nos processos por danos financeiros".

Entre esses casos, estão os dois dúzias de processos que governos estaduais e locais apresentaram contra empresas com combustíveis fósseis. Alguns dos demandantes nesses ações judiciais usaram estudos ligando as mudanças climáticas a eventos específicos como o furacão Maria onabet suporte 2024.

"Algumas pessoas se tornaram mais otimistas sobre o sucesso nesses processos por causa do surgimento da ciência de atribuição", disse Michael Gerrard, fundador dos Sabin Center for Climate Change Law na Universidade Columbia. Nenhum desses casos foi a julgamento ainda". Karen Zraick contribuiu com reportagens.
