Sports Betting Guide

Football Rules

- 1.- For betting purposes, a football game (pro or college) becomes official after fifty-five (55) minutes of play.
- 2.- Games lasting under 55 minutes constitute "No Action" or "Push/Cancel" and the bet will be void. However, if quarters are completed that constitutes action on quarters.
- 3.- Betting on the game period spread, moneyline, or total (over/under) include any overtime scoring.
- 4.- 2nd Half betting includes any overtime scores. Fourth Quarter betting does NOT include overtime scores.
- 5.- If a game goes to overtime, finishing with a tie all bet types will be valid. Basketball Rules
- 1.- For betting purposes, a basketball game becomes official after forty-three (43) minutes of play for pros, it is 48 MINUTES GAME, and thirty-five (35) minutes for all other leagues, it is 40 MINUTES GAME.
- 2.- Games lasting under official time constitute "No Action" or "Push/Cancel" and the bet will be void. However, if quarters are completed that constitutes action on quarters.
- 3.- 2nd Half betting includes any overtime scores. Fourth Quarter betting does NOT include overtime scores.

Hockey Rules

1.- For betting purposes, a hockey game (pro or college) becomes official after fifty-five (55) minutes of play.

Baseball Rules Regular Season

- 1. For game totals over (+) or under (-) will be valid when the team that's losing has exhausted there 9th inning. If the match is tied, a minimum of nine innings must have been played to be valid 2. All bets including: run line, super run line, run alt and money line will be valid when the losing
- team has hit their fifth (5th) inning. If the match is tied, minimum of five inning must have been played to be valid.
- 3. All play-to-play at half time will be valid when the losing team has hit their fifth (5th) inning. If the match is tied, a minimum of five full innings must have been played to be valid.
- 4. For halftime over (+) or under (-) will be valid when five full innings have been played.
- 5. For all solo (+) or solo (-) will be valid when the losing team has hit their (9th) inning. If the match is tied, a minimum of nine innings must have been played to be valid (extra innings are valid for over (+) or under (-).
- 6. First to score (FS) will be valid to the team that scores first, not the full inning and no matter how many innings are played for this mode (the game does not necessarily have to be official).
- 7. Will there be run scored in the first inning (YES-NO): all wagers will be considered official after first inning

- 8. Strikeout plays will be valid when the game is official, the team losing has hit the fifth (5th)inning.
- 9. Player proposition will be valid when the full inning has been exhausted. Player proposition will be valid when the losing team has hit their fifth (5th) inning. Both players muy start. RULES FOR MLB DOUBLE HEADER:

When a double game is scheduled and one of them is cancelled, for betting purposes the game played will be the first game and all bets on second game will be void.

RULES FOR MLB PRE SEASON GAMES:

All games played 9 innings or more will be valid for RUN LINE and TOTAL (over / under) BETS. Including those games which finished tie.

RULES FOR International Baseball Events:

All games end by mercy rule, slaughter rule, knockout rule, or skunk rule will be valid for RUN LINE and TOTAL (over / under) BETS.

Soccer Rules

- 1.- All bets are based on the result at full-time. The terms full-time, 90 minutes play, and normal time are all used to denote the period of play that includes injury time but not extra time, penalty shoot-outs, etc.
- 2.- If a referee declares a game ABANDONED for any reason, wagers will be void.
- 3.- If a referee declares a game FINAL for any reason before 90 Minutes played, wagers will be valid.

Player Propositions

1.- Any players involved on (basketball or football) player propositions bets must take action at least on second on the game, otherwise the bet will be considered void.

Baseball Player Matchup

- 1.- On Total Bases Propositions, both players must start. A batter is only credited for bases if he hits a single (1 base), a double (2 bases), a triple (3 bases) or a home run (4 bases). A walk, hit by pitch, error, balk, fielder's choice, or passed ball do not count for Total Bases Propositions.
- 2.- This bet will be considered void if the game does not comply with paragraph 1.- of the "baseball rules" section.
- 3.- This bet will be considered void if a player belongs to a team which is scheduled on double game.

Primeiro Rei George III. Agora Keir Starmer

Citando a revolução americana enquanto escreve "britânico", Donald Trump apresentou uma queixa extraordinária contra o Partido Trabalhista do Reino Unido pelo que alega ser "interferência" nas eleições presidenciais dos EUA.

A campanha de Trump alegou que nas últimas semanas, o Partido Trabalhista recrutou e enviou

membros do partido para fazer uma Campanha pelo seu oponente Kamala Harris melhor slot sportingbet estados críticos no campo da batalha na tentativa por influenciar a eleição presidencial.

"Quando representantes do governo britânico tentaram ir de porta melhor slot sportingbet casa na América, isso não acabou bem para eles", diz uma carta da equipe jurídica Trump à Comissão Eleitoral Federal.

"Esta semana passada marcou o 243 aniversário da rendição das forças britânicas na Batalha de Yorktown, uma vitória militar que garantiu aos Estados Unidos a independência política do Reino Unido" --uma tradução incorreta para 'Britain'.

A carta continua a pedir uma investigação imediata sobre "inferência estrangeira flagrante" na eleição sob forma de contribuições estrangeiras ilegais aparentes feitas pelo Partido Trabalhista do Reino Unido e aceita pela comissão da campanha Harris.

Também se refere a um relatório no Washington Post que afirma ter sido oferecido aconselhamento entre o Partido Trabalhista ea campanha Harris, bem como outros relatórios sobre reuniões com funcionários seniores do partido trabalhista.

A queixa faz referência a um post nas redes sociais, que parece ter sido excluído no qual Sofia Patel chefe de operações do Labour na semana passada e postou melhor slot sportingbet seu LinkedIn o fato dos 100 funcionários atuais ou antigos estarem indo para os EUA fazer campanha por Harris.

Entende-se que as viagens foram organizadas melhor slot sportingbet uma capacidade pessoal e alojamento foi organizado por voluntários para os democratas.

Mas o post da semana passada recebeu uma rápida reação dos republicanos, com a representante de extrema direita Marjorie Taylor Greene escrevendo melhor slot sportingbet X que "os estrangeiros não podem se envolver nas eleições americanas".

E Musk, o empresário bilionário que apoia Trump escreveu no X a plataforma de mídia social dele: "Isso é ilegal" - apenas para excluir um post depois da nota comunitária apontada não há lei impedindo estrangeiros melhor slot sportingbet participarem do bate-boca na porta.

A campanha de Trump seguiu-se na terça feira com melhor slot sportingbet queixa legal. Susie Wiles, cogerente da Campanha disse: "Em duas semanas os americanos rejeitarão mais uma vez a opressão do grande governo que rejeitamos melhor slot sportingbet 1776 e o inflexível Harris - Walz está buscando influência estrangeira para impulsionar seu radical mensagem – porque eles sabem não podem ganhar as pessoas americanas ".

"O presidente Trump vai voltar a força para o Casa Branca e colocar os Estados Unidos, nosso povo melhor slot sportingbet primeiro lugar. A aceitação da campanha Harris de usar esta assistência estrangeira ilegal é apenas mais uma tentativa fraca numa longa linha anti-americana interferência eleitoral."

Starmer, o primeiro-ministro britânico conheceu Trump durante uma viagem a Nova York no mês passado. O ator visitou melhor slot sportingbet torre dizendo que queria encontrar com ele cara após face porque "eu acredito muito melhor slot sportingbet relacionamentos pessoais na cena mundial".
