Um ataque israelense matou pelo menos 10 pessoas durante a noite no sul do Líbano, informou o Ministério da Saúde neste sábado. Militares de Israel disseram que ele tinha como alvo um

armazém na área usada por Hezbollah grupo miliciano libanês apoiado pela Irã

O número de mortos seria um dos maiores na volumosa onda diária quase cotidiana, que se

estende por 10 meses entre o Líbano e Israel sportsbet 765 Gaza. As tensões aumentaram ainda mais nesta região nas últimas semanas após os assassinatos do Hezbollah ou Hamas provocarem votos contra a nação israelense no país árabe

Os mediadores têm pressionado para evitar uma guerra mais ampla com um impulso diplomático concertado por cessar-fogo na Guerra de Israel sportsbet 765 Gaza. O secretário do Estado, Antony J Blinken está programado viajar a Jerusalém no sábado (24) e ajudar as negociações que estão sendo mediadas pelos Estados Unidos Egito - Qatar

Todas as pessoas mortas no ataque perto da cidade de Nabatieh eram cidadãos sírios, e incluíam uma mulher com seus dois filhos.

A mídia estatal libanesa disse que eles foram mortos quando caças israelenses atingiram uma fábrica de tijolos perto da cidade. Imagens circulando na imprensa local mostraram equipes escavadas nos escombros, levando as pessoas para a ambulância

O Exército israelense disse que estava "olhando para a alegação de vários civis foram prejudicados como resultado do ataque".

A doença pairou sobre o sul do Líbano e a região mais ampla desde que Israel matou um alto funcionário da Hezbollah no final de julho, sportsbet 765 resposta ao ataque libanês.

Um ataque retaliatório do Irã ou de seus representantes, que incluem o Hezbollah tem sido amplamente antecipado desde os assassinatos da comandante xiita sportsbet 765 Beirute e menos um dia depois Ismail Haniyeh (líder sênior) Israel reivindicou a autoria pela morte dele.

Autoridades norte-americanas, iranianas e israelenses disseram na sexta que o Irã decidiu adiar qualquer represália contra Israel para permitir aos mediadores continuarem trabalhando sportsbet 765 direção a um cessar fogo.

As negociações de alto nível para interromper a guerra terminaram sem um avanço imediato na sexta-feira, mas os Estados Unidos e o Catar disseram que as conversas continuarão semana passada enquanto mediadores correm pela trégua.
